## ROBERT MCGEE APPOINTED CHAIR OF SAFEGUARDING ADVISORY GROUP

ROBERT McGee is the new chair of the Archdiocesan Safeguarding Advisory Group (ASAG). He is currently a trustee of the Archdiocese. A recent consultation exercise proposed a revised structure of the group to allow for greater governance and clarity of remit and purpose.

### What is the Safeguarding Advisory Group?

ASAG ensures that high standards of safeguarding in the Archdiocese are maintained and is also the forum to propose new ideas for the benefit of safeguarding in the Archdiocese.

### Who is on it?

Archbishop Leo Cushley, Robert McGee (trustee and chair), Fr Allan Chambers (see right), Emma Boothroyd (see right), Elaine Anderson (see right) Fr Francis Ututo, Sheila Ritchie (DRAMT chair), Fr Marcin Motyka and two representatives from Catholic Education.

### What else?

A forum has been formed that will include safeguarding parish co-ordinators, trainers and reps from groups such as the SSVP and our Lourdes pilgrimage team. Issues of concern from the Forum will be escalated to the ASAG itself.

The DSA is responsible for managing all complaints and allegations of a safeguarding nature in accordance with 'In God's Image', the national safeguarding document.

## Priest is sentenced

FR Martins Enegbuma, a priest based in our Archdiocese, was given a four month restriction of liberty order at Edinburgh Sheriff Court on 15 March 2022 after being found guilty of a sexual assault at a parish house in Edinburgh. The Archdiocese has apologised to the victim and support has been offered to her and the priest.
